BE IT RESOLVED by the City Council of the City of Wilkes-Barre:

Whereas, Anthony MacFarland, owner of the Chill Grill, desires to install a sign (see attached), which will overhang the sidewalk right-of-way, onto the building located at 100 N. Pennsylvania Avenue.

Now, Therefore, Be It Resolved by the Wilkes-Barre City Council that approval is hereby granted contingent upon satisfaction of the following requirements:

File the following with the City Attorney's Office:

- 1. File liability insurance naming the City as an insured for any liability connected with the said request.
- 2. File a Release and Save Harmless Agreement.
- 3. The applicant and a successor shall file current liability insurance naming the city as an insured.



Signage for "The Chill Grill" at 100 N. Pennsylvania Ave., Wilkes-Barre, PA 18701

- Front of Building panel sign, single faced, non-lighted made of aluminum composite with vinyl graphic with name and logo. Sign will be mounted fast to brick with screws. Size 26"H x 87"W x 1/8" thick = sign cost = \$500
- 2. Oval Hanging sign  $28"H \times 41"W \times 1"$  thick hanging from bracket with 3 spring snap links/chain, with vinyl graphic applied to both sides. Sign cost = \$510
- 3. Vinyl graphics applied to side window above entrance door 18"H x 71.5"W, Front window graphics x 7 wording and pictures of food size to be determined, but not to cover entire window. Above door costs \$145 Window graphics to be determined.

Metal sign face square footage total (both front sign and hanging sign) = Approximately 32 square feet.
